Integrated First Line Response (IFLR) – Operationalization Status Report #3

June & July 2023



Key Highlights

- Camp Coordination and Camp Management (CCCM):** area-based meetings held in coordination with other CCCM partners; camp management committee trainings; better functioning of Zite Manager;
- Multi Purpose Cash Assistance (MPCA):** 4,966 households assisted in Beletweyne, Galkayo, Baidoa and Mogadishu, and launch of MPCA assessment into the H2R by DRC mobile teams
- In kind assistance:** Opening of new warehouse and improvement of stock prepositioning to operationalise the IFLR within the timeframe.
- Water, Sanitation and Hygiene (WASH):** Distribution of Essential Hygiene Items, training of 171 Community Hygiene Promoters 171 IDP sites in Mogadishu, Beletweyne, Belet hawa, Galkayo and Baidoa as well as identification and selection of IDP sites with sanitation coverage and targeted for latrine construction.
- Protection:** DRC Protection teams have been trained through 12 trainings of trainers on provision of PFA (psychological first aid) and are now providing this service.
- Information management:** roll-out of DRC's integrated information management system RESPOND for NAT2.0, NFI distributions, and MPCA.

Operational Challenges

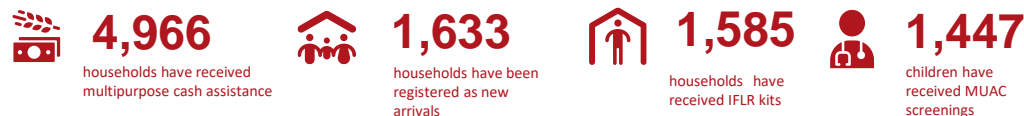
- CCCM:** Transition phase started to consolidate camps managed by DRC in a limited number of catchment areas instead of managing scattered camps which will take up to six months to complete the shift from certain camps to others.
- In kind:** not homogenous across area, still some improvement to deliver the first line blanket assistance on time in certain areas.
- MPCA:** Accumulated caseload from new arrivals, need of systematic approach for the second line response and referral to other actors - as DRC has only limited resource to address the needs of all new arrivals.
- WASH:** Land space for latrine construction limited in most IDP sites.
- Protection:** Mental Health and Psychosocial Support is a big gap and now such services are available.

Recommendations

- CCCM:** close coordination with cluster, communities, partners and authorities to ensure the involvement of all stakeholders and proper information sharing about the changes.
- In kind:** improving stock prepositioning management to enable faster in-kind distribution.
- MPCA:** coordination with actors to be able to deliver life-saving assistance for all new arrivals for the first 3-months.
- WASH:** when land space allows it, communal blocks of 6 latrine stances should be prioritised in IDP sites.
- Protection:** enhance coordination with food actors, specifically advocating for caseloads of vulnerable protracted IDPs.
- Information management:** include more sectors on RESPOND mainly IPA to complete the cycle of IFLR.

49 protection cases, including SAM/MAM have been identified, supported with IPA and referred to health and nutrition partners.

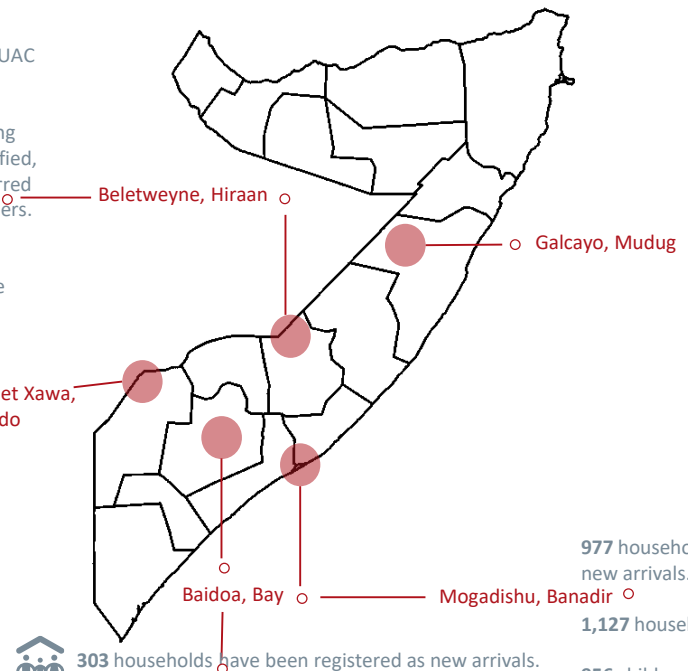
3,302 households received multipurpose cash assistance funded by ECHO.
